ORDINANCE NO. 22-037

AN ORDINANCE TO PROVIDE FINANCIAL SUPPORT TO THE CANAL WINCHESTER CHAMBER OF COMMERCE

WHEREAS, the Canal Winchester Chamber of Commerce provides service to the business community of Canal Winchester, contributing to the City's commercial, cultural, and financial wellbeing; and

WHEREAS, Council determines that it is a public purpose, and in the interest of the City of Canal Winchester, and consistent with the provisions of the Ohio Constitution and the Charter of the City of Canal Winchester, to provide direct financial assistance to the Canal Winchester Chamber of Commerce;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CANAL WINCHESTER, STATE OF OHIO, THAT:

Section 1. Council authorizes the Mayor to enter into an agreement with the Canal Winchester Chamber of Commerce ("the Chamber") to provide a grant to the Chamber in an annual amount of ten thousand dollars (\$10,000.00), for a period of up to three years, for the support of Chamber operations; such agreement shall require the Chamber to provide a report, on at least an annual basis, of its activities and its use of the grant funds.

Section 2. That this Ordinance shall take effect and be in force at the earliest date provided by law.
