# AN ORDINANCE TO REPEAL SECTION 951.02 OF THE CODIFIED ORDINANCES OF THE CITY OF CANAL WINCHESTER

WHEREAS, in order to eliminate due duplicity of rules governing park usage it is the recommendation of the Director of Public Service that Section 951.02 be repealed; and,

WHEREAS, Council hereby finds and determines that it is in the best interest of the City of Canal Winchester to repeal Section 951.02 of the codified ordinances.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CANAL WINCHESTER, STATE OF OHIO:

#### 951.02 HOURS AND REGULATIONS FOR GILBERT GUILER PARK.

- (a) The hours of operations of the Gilbert Guiler Park are set at 6:00 a.m. to dusk daily. (Ord. 32-06. Passed 5-1-06.)
- (b) The following regulations shall govern all public activities and use of the park during the hours of operation:
  - (1) No usage of alcohol or drugs shall be permitted on the premises at any time.
  - (2) No glass containers shall be permitted on the premises.
  - (3) No profanity shall be used on the premises.
  - (4) No fighting shall be permitted on the premises at any time.
  - (5) No unsafe use of playground equipment shall be permitted at any time.
  - (6) The playing of offensive music shall be prohibited at all times.

(Ord. 125-95. Passed 9-5-95.)

(7) No parking on private property by users of the Gilbert Guiler Park shall be permitted. Violators will be towed. Parking by users of the park is limited to the swimming pool parking lot.

#### 951.03 RULES FOR PARKS, PONDS AND LEISURE/MULTIUSE PATHS.

- (a) Park Rules:
  - (1) Hours of Operation: 6:00 a.m. to Dusk.
  - (2) No usage of alcohol or drugs shall be permitted on the premises at any time.
  - (3) No glass containers shall be permitted on the premises.
  - (4) No profanity shall be used on the premises.
  - (5) No fighting shall be permitted on the premises at any time.
- (6) Field and equipment availability will be dependent on weather conditions and may be closed due to weather.
  - (7) Damage to fields and equipment caused by misuse will be subject applicable laws.
  - (8) Field and equipment availability may be subject to previously scheduled events.
  - (9) No unsafe use of playground equipment shall be permitted at any time.
  - (10) The playing of offensive music shall be prohibited at all times.
- (11) Uauthorized motor vehicles (including but not limited to cars, trucks, motorcycles, mopeds, golf carts and motorized scooters and bicycles) are prohibited except in designated areas. Persons with disabilities are permitted to use a motorized wheelchair or similar means for transportation.
  - (12) Only leashed pets are permitted.
  - (13) Pet owners are required to remove of and dispose of their pet's waste.
  - (14) Overnight parking and camping are prohibited unless approved by City.
- (15) Use of firearms, fireworks, BB guns, archery equipment, sling shots and paint guns are prohibited unless authorized by the City.
  - (16) Illegal and/or inappropriate conduct will not be tolerated.
- (17) No person shall conduct, sponsor or promote a special event, concert, theater, athletic event/lesson or other public activity in a park without prior written consent of the City.
  - (18) All local, state and federal laws and ordinances apply.
  - (b) Ponds:
- (1) Boating, swimming, ice fishing, ice skating and walking on ice is prohibited, unless approved by City.
  - (2) Any bass or catfish under 16 inches in length must be released.
- (3) Hunting or collecting of frogs, turtles, birds or other animals on park property is prohibited unless otherwise authorized by law.
  - (4) Seining (casting of fish nets for purposes of catching fish) is prohibited.
  - (5) All other state and federal wildlife statutes shall be applicable.
  - (c) Leisure Paths:
    - (1) All City codes and state ordinances will be enforced.
- (2) Unauthorized motor vehicles (including but not limited to cars, trucks, motorcycles, mopeds, golf carts and motorized scooters and bicycles) are prohibited. Persons with disabilities are permitted to use a motorized wheelchair or similar means for transportation.
  - (d) <u>Penalty.</u> Violation of any of the above rules will result in the following penalties:
    - (1) 1st offense 30 days banned from the park
    - (2) 2nd offense 60 days banned from park
    - (3) 3rd offense 1 year banned from the park
    - (4) 4th offense banned for life
