F. Public Comments - Five Minute Limit Per Person

Allison Circle, Chief Customer Experience Officer, CML: With me is Lauren Hagen, our CFO, and Larry Corbus, who is a library consultant, and has been working with us on many of our projects; I'm here today to talk to you a little bit about our location here in Canal Winchester, which has been open for 4 years now; it is going Gangbuster's – here is something I bet you all know, I bet you know that Canal Winchester is a reading community; we have a lot of our branches that are really focused on social service needs, job help needs, or early literacy needs – what's really a big piece of Canal is the reading community here; our reserves at our location just around the corner here are actually one of our busiest of any of our locations at all; we started this as an experiment, because we didn't have a presence here, and the mayor and others had suggested we might want to work at getting presence; with you all, and with the mayor, we took over the location in the school; we have what we call is an express branch – the hours are shorter, and the services are minimal, to kind of test the waters, and see what the response would be; the response is great, between 2017 and 2018, circulation in the branch grew by 6%; this is at a time when in general, people are reading less; we have seen diminishment in our other locations, so that is a really impressive number; our visits grew by 3%; our homework help center grew by 46% in the last year – awesome, don't you think? Reading buddies, which is a program that prepares kids for the 3rd grade reading guarantee, grew by 28%; our computer use grew by 2% - our wireless usage, because our library offers free wireless, grew by 16%; Canal Winchester is our only location out of 23 which has seen growth in all of these categories; in our other locations, some have been up, and some have been down, but Canal Winchester is the only one that has grown in all of those; we have been exploring what it would take for us to expand our hours; that's probably the biggest question we are ever asked; we are exploring that, it would require us to add some staff so that we are open for more hours, but we are

hoping to do that yet this year; I'm going to pass something out here that I think you'll enjoy – one of the things that we have learned about all of our locations is that they draw from all over Franklin County; what I'm going to give you is some dot maps, which show in a visual way the address of someone who uses the Canal Winchester location, for both computer use and for use of our materials; you'll see that they come largely from here, but also – 'why are those people in Dublin using the Canal Winchester branch?', because we pull people from all over; that is representative of economic boon to various communities as well; that's all I have for you today, just wanted to give you an update; I haven't been able to be here, and share that with you; it's our pleasure to do that for you today.

Amos: Could you go into a little detail about your 3rd grade guarantee program? Circle: Yes; do you remember when the 3^{rd} grade reading quarantee was implemented – we had several schools come to us, saying 'oh my gosh, our kids are just so not ready'; we have a program that is after-school hours at all of our locations; volunteers work with kids, and it's important that the children actually read to an adult, it's not an adult reading to them; they practice their reading skills, they have little after-reading comprehension cards – looking at what the story was about, and all of that; this year, we are implementing a new program to drive that work even deeper; it's sometimes not enough to read fifteen minutes to an adult; we are starting to handle it a little more like case management – so we know that Lauren (for example) has trouble with saying the letter 'n', so we will note that, and when Lauren comes in, we will give her a book to read that really focuses on the letter 'n', write some homework for her to give to her parents, for them to practice at home; we are really trying to make this program much more robust, and more impactful to the lives of kids; Jarvis: First of all, thank you for extending what was probably an already long day for you, to come and share the good news with us; I felt that the library's success here is due in large part to the way you operate; I have a question – what do you think is behind the fact that Canal Winchester is one of the most utilized branches in your system? Circle: I think you have a great community here, there is a sense of community; it hadn't been here, there's not a long tradition of it being here; I don't think that it has a lot to do with the neighborhood and the community; we know that Hilliard just blows a lot of our reading out of the water, they are much bigger; some of the other statistics we have there might have gone down in one or two categories; i think it has a lot to do with what is attractive about your community; Walker: You have probably personally run into my father, Jack Walker – I know he probably takes 15-20 books out at a time, he will be 88 years old next month.

Lynch: I've got a quick question – the one in Hilliard is out on Leap Road, the brand new one? It's kind of out in the middle of nowhere, it's not walk-able; that still gets a pretty good population; Circle: Yes, it's also more of a driving community; it's moms with kids – actually, Lauren is from Hilliard – it's just a different style of community; they don't have this walkability that is so attractive about Canal; Lynch: What seems to be more – drivability, walkability? Circle: I don't know that there's really a difference, it's just a number of factors altogether.

Allison Saffle, VP of Member Services, South Central: We wanted to come and give you guys more of a formal announcement before we made the announcement to everybody in the community; just a little history about South Central Power – we are an electric co-op, so we operate a little differently than other utilities; we serve and are owned by our members that we serve; they have a lot of input in how we do things, and how we drive our business model; South Central Power – we have 120,000 members that go almost all the way to Wheeling, West Virginia, down to Cincinnati; currently today we have 5 district offices, we operate one in Barnesville, which is kind of the eastern side of the state, we have one in Hillsboro, which is kind of outside of Cincinnati; within the central Ohio region, we have one in Lancaster, one here in Canal off of Diley and Busey Road, and then one in Circleville; our facilities, like a

lot of things, are aging, so we had to take an approach to look at what we were going to do; most in particular our Lancaster office – we have been there for a long time, we currently don't have water and sewage; we truck in water, and we have our own sewer operating plant, so we have outgrown it; as you guys have seen a lot of growth in the Canal Winchester area and Pickerington, we have too; we've had a lot of new employees, and growth at the co-op in general; when we were walking through our facilities, we decided to hire some consultants to help us with what our plans were going to be; in the last 3 years, we were looking at what would be in the best interest of South Central in the long run, and also in the case of the membership, to make sure that we are doing what is best to keep their rates affordable; with that, we looked at the 3 offices within central Ohio – they're about 45 minutes apart – that's Lancaster, Circleville, and Canal, and have decided to consolidate those offices; we'll be consolidating them all into Lancaster, and we'll be moving to right off of 33 and the bypass, to the Rockmill Industrial Park; it's almost there at 33 and 188; if you know where the state highway patrol office is, that's where our new facility will be; I can tell you this, it wasn't an easy decision, as we have been in this community for a long time; not only do we fill a lot of service to our members, but we fill a lot of service to the communities, so we wanted to make sure that we were making the best decision for everyone; we felt that in the long run, this would be the better decision; consolidating will allow us to pay for the facilities by the savings we'll get through that consolidation; part of that is that we will not be laying off any employees, so we will be moving all employees; no one will be losing their job; we will be getting some savings through attrition as we go on over the years, because we know we will have some duplicate jobs or rerouting some people, but we won't be laying off anyone; we wanted you guys to hear it first – we thought as good neighbors and a good member of the community, and we plan to be a good member of the community, that you guys would hear it from us; our plan is to sell all 3 of those facilities; our facility over on Coonpath will be up for sale in about 2 years, we are thinking it will take about 2 years to build a facility, and then the one in Canal off of Diley and Busey Road, and then the one in Circleville that's off of Chickasaw and Tarlton will be up for sale at that point in time; I don't know if anyone has any questions for us, but we just wanted you guys to hear it first; we have kind of lightly told some of our members at some of the member meetings we've had; we did just recently put it in our Ohio Cooperative Leading Magazine, so members will be getting it in the next day or 2; we plan to do a more public press release once we have the ability to tell everyone that we wanted to hear it from us personally; Jarvis: This feels a little bit like a breakup; we do appreciate you coming and letting us know before we read about it; you'll still continue to service this area, it's an internal decision, we understand; Saffle: Yes, our commitment to the community will not change; if anything, with us moving facilities out, we're going to make a stronger commitment to make sure that you guys know we have a big presence here; this community is very important to us.

Clark: I would just like to say that we look forward to working with you to repurpose the facility down the road, and hopefully bring a nice employer for us in; Saffle: As we work through this over the next 2 years, we would definitely like some input in making sure that we are picking a good asset for you guys in the community; it's roughly about 30 employees that would be leaving this office.

Mayor's Report

19-039 Mayor's Report

Mayor: Thank you Mr. Jarvis, I really don't have a whole lot in addition to my written report – I would like to emphasize that last Saturday, a few of the employees of the city and the community watch, and Deputy D'Amore were at Diley Ridge for the Prescription Drug Takeback Day; we took in 103 pounds of drugs – not a record, but that's probably a good thing; I want to remind you that May 15th is our Relay for Life dinner.

Fairfield County Sheriff - Thank you, I do not have a written report for the night, I will have that for you on the 20th; as far as the speed complaints on East Waterloo Street, I do have the community watch doing speed surveys on that; I should have the data sometime this week; I've been having them do it for the last 2 weeks; I did assign Deputy Vaughn in that area on 2nd shifts, and Deputy D'Amore to do traffic control in that area on first shift; Bennett: As they have been doing the speed studies out there, or patrol, how many tickets have been issued over the last – Cassel: That I don't know, we talked about previously that we don't keep those stats per street; that's something that the sheriff's office has never

kept; Bennett: Thank you; Jarvis: Speaking of the sheriff's office, I saw the results of the county-wide survey that was done; your department received high marks in just about everything; congratulations on that; Cassel: Thank you.

Law Director - Thank you Mr. Jarvis and members of council; a couple of things this evening — did distribute the memo that was requested with regard to texting while driving; read through that, obviously we are going to need to do something, because we at least need to get that ordinance updated; something usually our codifier would do, and I'll have to see why that was not tracked by the codifier; we need to get it up to snuff with regard to state law; state law it's still a secondary offense — the other approach with respect to hands-free makes that a primary offense, and that will be the only legal issue, the rest would be policy issues; you'll see in the memo it's just — it's not good, bad, or indifferent, it's just not been tested in the court as to whether under home-rule we would have the ability to make something that's state law specifically designated a secondary offense into a primary offense; it's a little bit of a gray area, but obviously read through the memo, maybe we can go into a little more detail the next meeting; I do request an executive session, even though the Blue Jackets are playing, at the end of the regular meeting; as you know, we can — it's up to council's discretion to invite into executive session anybody they so choose — this evening, since they're here, and they didn't bring any books to read, we would like to invite the library representatives into the executive session; it is for purposes of purchase or sale of real estate.
