## **ORDINANCE NO. 21-006**

## AN ORDINANCE TO AUTHORIZE THE MAYOR TO ENTER INTO A CONTRACT WITH AMERICAN BORING, INC. FOR THE McGILL PARK UTILITY IMPROVEMENTS PROJECT AND DECLARING AN EMERGENCY.

WHEREAS, it is the recommendation of the Design Engineer and the Construction Services Administrator to award the contract for the McGill Park Utility Improvements Project to American Boring, Inc.; and

WHEREAS, Council hereby finds and determines that it is in the best interest of the City of Canal Winchester to enter into a contract with American Boring, Inc. for the McGill Park Utility Improvements Project;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CANAL WINCHESTER, STATE OF OHIO:

Section 1. That the Mayor be and hereby is, authorized to enter into a contract on behalf of the City of Canal Winchester with American Boring, Inc. in the amount of \$648,797.42 for the McGill Park Utility Improvements Project.

Section 2. That this ordinance is hereby declared to be an emergency measure, necessary for the preservation of public health, safety, and welfare, such an emergency arising from the need to meet a specific construction schedule; wherefore this ordinance shall take effect and be in force from and after its passage.
